Kami telah mengaudit laporan keuangan **Yayasan Penabulu** terlampir, yang terdiri dari laporan posisi keuangan tanggal 31 Desember 2020, serta laporan aktivitas, dan laporan arus kas untuk tahun yang berakhir pada tanggal tersebut, dan suatu ikhtisar kebijakan akuntansi signifikan dan informasi penjelasan lainnya.

Tanggung jawab manajemen atas laporan keuangan

Manajemen bertanggung jawab atas penyusunan dan penyajian wajar laporan keuangan tersebut sesuai dengan Standar Akuntansi Keuangan di Indonesia, dan atas pengendalian internal yang dianggap perlu oleh manajemen untuk memungkinkan penyusunan laporan keuangan yang bebas dari kesalahan penyajian material, baik yang disebabkan oleh kecurangan maupun kesalahan.

Management's responsibility for the financial statements

Management is responsible for the preparation and fair presentation of such financial statements in accordance with Indonesian Financial Accounting Standards, and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

Auditor's responsibility

Our responsibility is to express an opinion on such financial statements based on our audit. We conducted our audit in accordance with Standards on Auditing established by the Indonesian Institute of Certified Public Accountants. Those standards require that we comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether such financial statements are free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the auditor's judgment, including the assessment of the risks of material misstatement of the financial statements, whether due to fraud or error.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.



A. INFORMASI UMUM

1. Pendirian dan Informasi Umum

Yayasan Penabulu didirikan berdasarkan Akta Notaris nomor 01 pada tanggal 22 Oktober 2003, dibuat dan disahkan oleh notaris Rita Riana Hutapea SH, di Jakarta. Kemudian perubahan akta pendirian yayasan tanggal 15 April 2004 nomor 02 oleh notaris Rina Riana Hutapea SH, yang telah disahkan oleh Menteri Kehakiman dan Hak Asasi Manusia Republik Indonesia nomor C-435 HT.01.02.TH.2004 tanggal 5 Agustus 2004. dan Akta Perubahan Pernyataan Keputusan Rapat Yayasan Penabulu tanggal 25 Mei 2016 nomor 07 dengan notaris yang sama yang telah mendapat Surat Penerimaan Perubahan Data dari Kementerian Hukum dan Hak Asasi Manusia Republik Indonesia tanggal 31 Mei 2016 No. AHU-AH.01.06-0002440, serta Akta Perubahan Pernyataan Keputusan Rapat Pembina Yayasan Penabulu tanggal 11 Desember 2017 nomor 3 oleh Notaris Kokoh Henry, S.H,M.Kn dan telah mendapat Surat Penerimaan Perubahan Data dari Kementerian Hukum dan Hak Asasi Manusia Republik Indonesia tanggal 12 Desember 2017 nomor AHU-0022669.AH.01.12.TAHUN 2017, serta Akta Pernyataan Keputusan Pengurus Yayasan Penabulu tanggal 24 Oktober 2018 nomor. 29, 30, 31 oleh Notaris Kokoh Henry, S.H., M.Kn, dan Akta Pernyataan Keputusan Pengurus Yayasan Penabulu tanggal 12 November 2019 nomor 11 oleh Notaris Kokoh Henry, S.H.,M.Kn.

Yayasan Penabulu berkedudukan dan berkantor pusat di Jakarta. Yayasan Penabulu mempunyai visi masyarakat Indonesia yang berdaya. Sedangkan misinya adalah mendorong keberdayaan dan keberlanjutan posisi dan peran organisasi masyarakat sipil di Indonesia melalui upaya penguatan kapasitas dan kapabilitas organisasi; mobilisasi, pengelolaan dan penyaluran sumber daya; pengembangan kemitraan setara antar sektor pembangunan serta penggalangan partisipasi dan keterlibatan publik seluas-luasnya.

A. GENERAL INFORMATION

1. Establishment and General Information

Penabulu Foundation was established based on deed number 01 dated October 22, 2003 by Rita Riana Hutapea, S.H., in Jakarta. Notary then change the deed of establishment of the Penabulu Foundation on April 15, 2004 number 02 by Rita Riana Hutapea, S.H. Notary verified by the Minister of Justice and Human Rights of the Republic of Indonesia number C-435 HT.01.02.TH.2004 dated August 05, 2004 and deed Change Statement Meeting of Penabulu Foundation dated May 25, 2016 number 07 by the same notary that has received the data acceptance letter from the Ministry of Justice and Human Rights of the Republic of Indonesia dated May 31, 2016 No. AHU-AH.01.06-0002440, and deed Change Statement Meeting Governing Board of Penabulu Foundation dated December 11, 2017 number 3 by Kokoh Henry, S.H.,M.Kn. Notary and has received the letter of acceptance of data from the Ministry of Justice and Human Rights of the Republic of Indonesia dated December 12, 2017 number AHU-0022669.AH.01.12.TAHUN 2017, and deed Change Statement Meeting Executive Board of Penabulu Foundation dated October 24, 2018 number 29, 30, 31 by Kokoh Henry, S.H.,M.Kn. Notary, and deed Change Statement Meeting Executive Board of Penabulu Foundation dated November 12, 2019 number 11 by Kokoh Henry, S.H.,M.Kn. Notary.

Yayasan Penabulu domiciled and headquartered in Jakarta. Penabulu Foundation has a vision Empowered Indonesia Civil Society. While its mission is encourage the empowerment and sustainability of the position and role of civil society organizations in Indonesia through efforts to strengthen the capacity and capability of the organization; mobilization, management and distribution of resources; the development of an equal partnership with other development sectors, as well as raising the public participation and involvement.

Penablu kini mendorong dirinya untuk mengambil peran sebagai 'civil society resource organization'. Sebagai organisasi sumber daya bagi masyarakat sipil di Indonesia, Penablu akan berusaha sebaik-baiknya memobilisasi, mengelola dan menyalurkan sumber daya dalam bentuk apapun demi mendukung kerja-kerja masyarakat sipil di Indonesia.
